GOVERNMENT OF UTTAR PRADESH (UP) AND GARENA SIGN MEMORANDUM OF UNDERSTANDING (MOU) TO PROMOTE ESPORTS IN UP USING YOTTA'S LOCAL DATA CENTRE INFRASTRUCTURE
